

**Flight Centre 2019 Global Gathering
Air New Zealand Incentive Terms and Conditions:**

Promotion period is 1 April - 21 June 2019. Incentive open to consultants of Flight Centre Travel Group (FCTG) in wholly owned markets of Australia, UK/Ireland, New Zealand, USA and Canada. There is a total of twenty (20) Grand and Major winners selected for the promotion, ten (10) Grand prize winners, ten (10) Major prize winners, there will also be selected spot prize winners in each region throughout the duration of the promotional period.
